## THE TENDENCIES OF DEVELOPMENT OF SMALL CONSTRUCTION ENTERPRISES IN SAMARA REGION

*Keywords:* competition, adaptation, small business, building, self-regulating organizations, region development.

The article considers the role of small business in region development, modern condition of small construction enterprises in Samara region and the perspectives of their development at a time when laws about self-regulating organizations in building are adopted.

Success of industry development generally, and enterprises of construction complex in particular defines the economic potential of industrial countries. Small business has important social-economic meaning in that strengthening. This segment able to provide the stable growth of economy of state, supporting competition, the implementation of innovation technologies, developing new directions of business.

Found on the experience of countries with high-developed economy, we can confirm that a lot of problems of region development are solved faster by means of small business: demonopolization, the formation of market structure of economy and competitive environment; the saturation of market by goods and services; providing of employment; economic growth and increasing tax payments; the formation of middle class; the strengthening of business ethic and tax discipline.

We should separate base characteristics of small business:

 This is special sector of economy, formed by aggregate of small marketable organizations and which is specific social-economic form of small industry in conditions of market, as sector of economy of national, regional and local scales; • This is special type of activity, based on initiative, innovation, hazardous base with a purpose getting of entrepreneurial income.

We can give generally estimate the small business of region on basis of a few indexes: the number of small organizations, their specific weight in the aggregate of region enterprises; number of working people; work volume, made by theirs etc.

Mentioned above statistical data verifies the stabilization of large and small construction enterprises in region.

It is very important that 61,2% person from all workers in construction work in small organizations in Samara region. This is confirmation that the small business is a successful with the function of providing of population employment in this region.

Nowadays governmental actions much is criticized. The data of statistics about the profitability of building organizations in Samara region verifies that accepted measure of supporting bring the benefit: clear profit of small enterprises according to the results 2007 year and composed 1 088 068 thousand of rubles, that this index exceed the index of large business almost in 2 times. Clear profit per one employee in large enterprise composes 22, 28 thou-

sand of rubles/person in 2007 year, but in small - 29,0 thousand of rubles/person. So, the deposit of small building enterprises in development of region is so important, also the growth potential of these organizations.

There was accepted law about self-regulation in building for providing good quantity of building production (Chapter 6.1 of Planning Code of Russian Federation, which was accepted by Federal Law, 22.07.2008 N148).

Accepting law is very important for the development of small building business. It is connected with requirements to entry in self-regulated organizations, members of which realizes the building. Special meaning among these requirements is that self-employed entrepreneurs and (or) legal persons must be not less 100 and compensatory fund is form in size not less than 1 000 000 rubles per one member of this organization.

These requirements are very important for small organizations, because payment in size 1 million of rubles is too much since according to the aggregate data the clear profit of small construction organization in Samara region composed 298 thousand of rubles, (profit of one large or average, for example, - 4223,1 thousand of rubles).

The one of the variants of small business development will promote to the merging of organizations. Further this allows to compete with competitors. Considering 4 item 4 part 55.5 article 6.1 chapter of Planning Code of Russian Federation about the non-admission or the limit of competitive. This help to align the effective collaboration inside organization, equally distribute the responsibility and competitive advantages that will provide the favorable perspectives of small business development. Competitive environment is formed not only at the expense of small organizations but also it stimulates every separate organization to the supporting of competitive ability on the market.

Creating of self-regulating organizations will promote to decreasing of unfair competitive by creating mutual responsibility.

Small business possesses the maximal opportunities of adaptation to changes of their components of market environment since it is solely dynamic and flexible. Main source and condition of that dynamics is a self-development. Evidently that small building enterprise exists successfully and has positive tendencies of development in Samara region.
